Notice is hereby given that the Board of Millard County Commissioners will conduct a public hearing on Tuesday, February 20, 2018 at 11:00a.m. at the old Millard County Courthouse, 50 South Main, Fillmore, Utah, for the purpose of receiving public comment on a Zoning Ordinance Map Amendment application to change the zoning of the properties described below from Range & Forest (RF), Agriculture (Ag), and Agriculture 20 (A 20) to Heavy Industrial (HI) for property located south of the Intermountain Power Project (IPP) near the intersection of Brush Wellman and Jones Roads, approximately 8 miles north of Delta; and more particularly described as:
