

QUALIFICATIONS

Before the filing officer accepts any declaration of candidacy, the filing officer shall read to the candidate the constitutional and statutory requirements for candidacy, and the candidate shall state whether he/she fulfills the requirements. If the candidate indicates that he/she does not qualify, the filing officer may not accept his/her declaration of candidacy (Utah Code Section 20A-9-201, 202).

COUNTY COMMISSIONER

Utah Code 17-16-1; 17-53-202

- Registered voter for at least one year before the date of the election
- Be a registered voter of the county which the member represents
- At least one year resident of the county immediately before the date of the election.
- Not convicted of a felony*
- Pay a filing fee of **\$249.83**

COUNTY RECORDER, TREASURER

Utah Code 17-16-1

- Registered voter in the county.
- At least one year resident of the county immediately before the date of the election.
- Not convicted of a felony*
- Pay filing fee of **\$393.05**

COUNTY ASSESSOR

Utah Code 17-16-1; 17-17-2

- A registered voter in the county.
- At least one year resident of the county immediately before the date of the election.
- Those candidates seeking the office of county assessor in a first through third class county must be a state-licensed or state-certified appraiser before filing for office. All other candidates for county assessor shall be a state-licensed or state-certified appraiser before the expiration of 36 months from the day on which the person's term of office begins.
- Not convicted of a felony*
- Pay filing fee of **\$393.05**

*A person convicted of a felony loses the right to hold office until (1) all felony convictions have been expunged, OR (2) ten years have passed since the most recent felony conviction AND the person has paid all court-ordered restitution and fines AND the person has completed probation, been granted parole, or completed the term of incarceration associated with the felony.
