

I, Marki Rowley, Millard County Clerk, hereby give notice pursuant to Utah Election Code 20A-5-101 for the 2022 election.

- The Declaration of Candidacy filing period for qualified political party candidates begins on Monday, February 28, 2022 and ends at 5:00 p.m., Friday, March 4, 2022, and;
- The Declaration of Candidacy filing period for state and local school board candidates begins on Monday, February 28, 2022 and ends at 5:00 p.m., Friday, March 4, 2022, and;
- The Declaration of Candidacy filing period for justices and judges of a court of record begins Friday July 1, 2022 and ends at 5:00 p.m., Friday, July 15, 2022, and;
- The Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Monday, January 3, 2022 and ends at 5:00 p.m., Friday, March 4, 2022, and;
- Candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office.
