- The Declaration of Candidacy filing period for qualified political party candidates begins on Tuesday, January 2, 2024 and ends at 5:00 pm., Monday, January 8, 2024 and;
- The Declaration of Candidacy filing period for local board of education candidates begins on Tuesday, January 2, 2024 and ends at 5:00 pm., Monday, January 8, 2024 and;
- The Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Tuesday, January 2, 2024 and ends at 5:00 pm., Monday, January 8, 2024;
- The Declaration of Candidacy filing period for registered political party candidates begins on Tuesday, January 2, 2024 and ends at 5:00 pm., Monday, April 29, 2024 and;
- The Declaration of Candidacy filing period for justices and judges of a court of record begins Monday, July 1, 2024 and ends at 5:00 p.m., Monday, July 15, 2024.
- Qualified political party candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office and;
- Registered political party candidates must submit nomination petition signatures no later than April 1, 2024.
